



بيان مشترك – JOINT STATEMENT

إدانة جريمة الحرب الإسرائيلية في غزة "نشعر بالصدمة والألم، ونطالب بحماية المدنيين وعمال الإغاثة الإنسانية"

نعبر عن بالغ صدمتنا، وعظيم ألمانا، للجريمة اللاإنسانية التي ارتكبتها القوات الإسرائيلية ضد عمال الإغاثة الإنسانية في مدينة دير البلح بقطاع غزة الفلسطيني، وقيام الطيران الإسرائيلي بقصف مركبة تابعة لمنظمة المطبخ المركزي العالمي الأمريكية "World Central Kitchen"، أدت إلى سقوط 7 ضحايا من العاملين في تقديم الإغاثة الإنسانية التي تقوم بها المنظمة بتنسيق دولي يشمل الحكومة الإسرائيلية، وذلك يوم الاثنين الموافق 1 أبريل 2024 أثناء قيامهم بتفريغ حمولة الأغذية التي وصلت إلى قطاع غزة بحراً قادمةً من قبرص.

وإذ نتقدم ببالغ التعازي لأسر الضحايا وعائلاتهم، ولشعب وحكومة استراليا وبولندا والمملكة المتحدة والولايات المتحدة الأمريكية وكندا وفلسطين، وإلى الرئيس التنفيذي لمنظمة المطبخ المركزي العالمي السيد إيرين غور، ولكافة العاملين والمتطوعين في المنظمة، متمنين الشفاء العاجل للمصابين والجرحى، فإننا نطالب بضرورة قيام مجلس الأمن الدولي يتحمل مسؤولياته في فرض احترام قواعد القانون الدولي الإنساني، لاسيما ما يتعلق بحماية المدنيين والعاملين في تقديم الإغاثة الإنسانية، وتطبيق قراراته المتعددة ذات العلاقة. مستذكزين بفخر أرواح الضحايا الخالدة، وما قدموه من عمل سامٍ جسّد الروح الإنسانية النبيلة، مؤكدين على أن هذه الجريمة اللاإنسانية، تتجاوز كيان المنظمة ذاتها، وتمتد إلى كافة منظمات المجتمع المدني بالعالم.
